Reports

- 1. State of the Society: Marcia Pool, AEMB Executive Director
 - a. New members
 - i. 22 chapters are inducting new members (6 chapters dues still need to be paid but they submitted near end of the semester)
 - ii. 270 inducted members in spring 2015
 - b. New chapters: total 44 approved chapters
 - i. University of Memphis (2015)--approved
 - ii. University of Maryland (2015)—approved
 - iii. Indiana Tech (2015)—waiting on updates
 - iv. The Catholic University of America (2015)—pending but close
 - v. University of Illinois at Urbana Champaign (2015)—approved
- 2. Treasurer's Report: Alicia Fernandez, National Treasurer
 - a. June 2014 we had \$31,356.20
 - b. May 2015 we have \$29,695.84
 - c. New vendor for honor cords saving us \$2890 per 1000 cords. The new cords are double cords instead of single cords and look nice. Same color as previous cords. In December 2014, 1008 (84 dozen—unit of purchase) cords were purchased for \$3141.00.
 - d. Continuing to use the previous vendor for honor pins, as they have ours developed and another place would have to recreate it. In December 2014, 1025 (ordered 1000 but they go over usually due to manufacturing) honor pins were purchased for \$4095.53.

 - i. Students submit original design idea on wearable devices or telemedicine
 - ii. Group students and train them in product design (regulatory design, market considerations, quality control, IP)
 - iii. Online resources/worksheets
 - iv. Develop an elevator pitch at the end
 - v. Resources for students
 - vi. Would like to grow workshop and have participating students return to help new workshop students
 - vii. Terri will send out the 2 page summary to the BOD
 - viii. Phone meeting with program director next week
- 3. Industry partners and resume book, Dominic
 - a. Collaborating with BMES to have an industry panel (1-2 hour; 1.5 hour is suggested time); want to get 6 representatives
 - b. Terry Young is the BMES contact
 - c. Justin Huckaby (AEMB student officer) leading this and has received 2 commitments from industry; waiting on Terry Young from BMES to provide a list also
 - d. David Wolfson (AEMB student officer) is developing a template for students to submit the resume which can be developed into an AEMB resume book that can be given out to industry
 - e. Industry council of AIMBE may be able to serve on panel
 - i. Herb would like to increase alliance between AEMB and AIMBE

- 5. Building awareness: AEMB Booth at BMES, give-away items, Marcia

 - b. Enhance name recognition

 - d. Allow us to build up email list; encourage students to become members
